Provide facilities to allow cleaning of contaminated footwear etc.			



Introduce visitors on arrival to farm dogs and confirm if noise/fear/ phobia issues exist (also included in pre-visit information form).	Keep pets indoors away from visitors if identified preference/phobia.	Appointe d volunteer S.Wood		
Fuel storage tank	All visitors – personal contamination, fumes, burns.	Keep fuel tank locked and away from access.				
Animal feeds	Animal feeds are in closed cupboard or feed bin. All visitors - ingestion of feeds or contamination with micro organisms.	Prevent access to feed stores.	Supervision of feeding animals. Washing facilities.	Appointe d volunteer S.Wood		
Chemical and veterinary products	All visitors - ingestion of harmful chemicals, breathing vapour or skin; contamination.	Chemical and veterinary products locked away in a suitable store.	Supervision if unlocked at the time due to milking in progress.	Appointe d volunteer S.Wood		
Food, refreshme nts	Visitors who eat food supplied at venue - food poisoning, illness.	Provider has food hygiene certificate and HACCP. Only food prepared by Bull Shed staff.		Bull Shed staff
